On May 10, Terina learned she has stage 3 cervical cancer. She has undergone chemotherapy and radiation treatment in Billings and needs to go back for more.

Terina has no medical insurance, and her medical bills have exceeded \$90,000. Her remaining treatment in Billings will cost about \$8,400 each week. In addition, she has travel expenses while also trying to maintain her home in Helena.



In spite of her illness, Terina recently opened Little t's Soup & Sandwich Shop in the Capital Hill Mall. With her new business up and running, she hopes to obtain insurance soon.
